- Share overhead and systems
- Exit as a portfolio for 10x

Real Example: My ADU Company

Bought for: \$380,000

Owner's stated revenue: \$1.2M

Actual revenue after cleanup: \$1.8M Current monthly profit: \$42,000

Time to manage: 3 hours/week
