## **The Empire Building Formula**

- Year 1-2: Master single business (\$1-3M)
- Year 3-4: Scale to 3-5 businesses (\$10M)
- Year 5-7: Regional consolidation (\$25M)
- Year 8-10: National platform (\$50M+)
- Year 10+: Generational wealth (\$100M+)

## **The 10-Year Wealth Building Plan**

### **Phase 1: Foundation (Years 1-2)**

#### **Business 1: Learn the Game**

- Target: \$1-2M revenue service business
- Focus: Systems and processes
- Goal: 2x EBITDA in 18 months
- Exit: Keep or sell for 3-4x profit

#### **Key Milestones:**

- Month 6: Profitable and stable
- Month 12: Management in place
- Month 18: Ready to scale
- Month 24: Second acquisition

## **Phase 2: Expansion (Years 3-4)**

### **Portfolio Building**

- Add 1-2 businesses per year
- Mix of industries for stability
- Geographic concentration for efficiency
- Combined revenue: \$8-12M
- Central office established

### **Infrastructure Development:**

- Hire portfolio CFO
- Centralized accounting
- Management development program
- Acquisition team formed

## **Phase 3: Consolidation (Years 5-7)**

### **Platform Creation**

- Focus on 1-2 best industries
- Roll-up strategy execution
- 15-20 locations/businesses
- \$25-40M combined revenue

- Professional board established

## Phase 4: Empire (Years 8-10+)

### Institutional Scale

- \$50-100M+ revenue platform
- Multiple exit options
- Generational wealth created
- Legacy business built

## Portfolio Architecture

### The Optimal Mix

### Industry Diversification:

- Essential services: 60%
- B2B services: 25%

- Specialty/niche: 15%

## Building Your War Chest

### Capital Accumulation Strategy

#### Year 1-2: Bootstrap Phase

- Reinvest 80% of profits
- Build banking relationships
- Establish credit lines
- Target: \$500k liquidity

#### Year 3-5: Growth Capital

- First outside investors
- Asset-based credit facility
- Partner with family offices
- Target: \$2-5M available

#### Year 5+: Institutional Capital

- Private equity partnerships
- Acquisition facility
- Subordinated debt
- Target: \$10M+ available

### The Tech Stack That Scales

#### Core Infrastructure:

- **ERP:** NetSuite or SAP Business One
- **CRM:** Salesforce or HubSpot Enterprise
- **BI:** Tableau or Power BI
- **HRIS:** Workday or BambooHR
- **Communication:** Slack + Microsoft Teams

#### Reporting Cadence:

- Daily: Cash position, sales

- Weekly: KPI dashboard
- Monthly: Full P&L review
- Quarterly: Board package

## Exit Strategy Evolution

### Your Exit Options by Size

#### **\$5-10M Revenue:**

- Strategic buyers: 3-4x EBITDA
- Competitor consolidation
- Management buyout

#### **\$10-25M Revenue:**

- Lower middle market PE: 4-5x
- Strategic platforms: 5-6x
- Partial liquidity options

#### **\$25-50M Revenue:**

- Mid-market PE: 5-7x
- Public strategic: 6-8x
- Dividend recap possible

#### **\$50M+ Revenue:**

- Institutional buyers: 7-10x
- IPO potential
- Family office buyers
- SPAC opportunities
